Introduction

We have reviewed the accompanying condensed interim consolidated financial statements of a Group (the Group), in which the parent entity is Silvair, Inc. (the Parent) with its registered office in 717 Market Street, Suite 100, San Francisco, USA, which comprise the interim consolidated statement of financial position as of June 30, 2020, the interim consolidated statement of profit or loss and other comprehensive income, interim consolidated statement of changes in equity, interim consolidated statement of cash flows for the period from January 1, 2020 to June 30, 2020 and selected explanatory notes.

The Board of Directors of the Parent is responsible for the preparation and presentation of these condensed interim consolidated financial statements in accordance with International Accounting Standard 34 *Interim Financial Reporting* published in the form of European Commission regulations.

Our responsibility is to express a conclusion on these condensed interim consolidated financial statements based on our review.

Scope of Review

We conducted our review in accordance with National Standard on Review Engagements 2410 consistent with International Standard on Review Engagements 2410 *Review of Interim Information Performed by the Independent Auditor of the Entity* adopted by the National Council of Statutory Auditors' resolution No. 3436/52e/2019 of April 8, 2019. A review of interim financial information consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than audit conducted in accordance with National Standards on Auditing consistent with International Standards on Auditing adopted by the National Council of Statutory Auditors' resolution No. 3430/52a/2019 of March 21, 2019 (as amended), and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

Conclusion

Based on our review, nothing has come to our attention that causes us to believe that the accompanying condensed interim consolidated financial statements are not prepared, in all material respects, in accordance with International Accounting Standard 34 *Interim Financial Reporting* published in the form of European Commission regulations.

Material Uncertainty Related to Going Concern

The Board of Directors of the Parent in the note to the condensed interim consolidated financial statements *Basis of Going Concern* informed about preparing the condensed interim consolidated financial statements on a going concern basis, presented impact of pandemic situation on the Group's activity and operations taken to provide the Group with financing its operations in the foreseeable future. The condition described indicates the existence of significant uncertainty, which may raise significant doubts on the Group's ability to continue as a going concern. In the aforementioned note, The Board of Directors of the Parent also presented activities aimed at reducing operating costs, while ensuring the continuity of contracts with key partners of the Group and the obtained financing. In the opinion of the Board of Directors of the Parent, these activities will be successful, however, there is no such certainty. Our opinion is not modified in respect of this matter.

Basis for Audit

The accompanying condensed interim consolidated financial statements is not consolidated financial statements within the meaning of regulations obtained in Poland.
